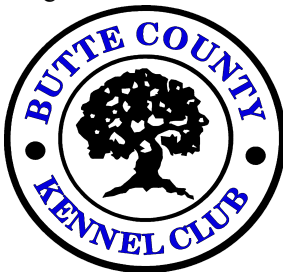

ATTENTION EXHIBITORS

The Show Site will be available to exhibitors on October 30, 2026 at 2:00 pm. Dogs must be removed from the show site immediately following Best in Show judging on November 1, 2026.

The following breeds may be judged on the ground or on a ramp: Nova Scotia Duck Tolling Retrievers, American Water Spaniels, Boykin Spaniels, Field Spaniels, Welsh Springer Spaniels, Grand Basset Griffon Vendéens, Norwegian Elkhounds, Whippets, German Pinschers, Portuguese Water Dogs, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Staffordshire Bull Terriers, Finnish Spitz, Entlebucher Mountain Dogs, Finnish Lapphunds, Icelandic Sheepdogs, Norwegian Buhunds, Australian Cattle Dogs, Polish Lowland Sheepdogs, Basset Fauve de Bretagne and Norrbottenspets (Misc).

The following breed may be judged on the ground, a ramp, or on a table: Miniature Bull Terriers.

The following breeds may be judged on a ramp or on a table: Basenjis, Mudik and Pulik

The following breeds must be judged on a ramp through all levels of conformation competition: Lagotto Romagnolo, Clumber Spaniels, English Springer Spaniels, Sussex Spaniels, Basset Hounds, Cirneco dell'Etna, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden and Spanish Water Dogs.

An AKC Recording Fee and Service Fee of \$4.50 for each entry. An AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any 4 & Under 6 Months Puppy and Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.)

CANADIAN/FOREIGN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

Entries received prior to the published opening date and time of entries or received prior to the publishing of this premium list will be returned without processing.

A service/processing fee of \$7.00 will be charged to each duplicate entry.

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs allowed in rings during judging only.

Dogs must be ready for judging. Neither the club nor its Superintendents will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

The Club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed the day of the show - None will be mailed.

All checks issued as prizes are the sole responsibility of the recipient. Lost, stolen and/or misplaced checks will not be replaced. Checks are valid for 90 days. The Superintendent is not able to cash checks nor will they be accepted toward entry fees.

RETURNED CHECKS/DECLINED CREDIT/DEBIT CARDS do not constitute a valid entry fee. Fees must be paid in guaranteed funds. Checks will not be accepted. The Superintendent will add a fee for completing the transaction and/or reprocessing the entries. Repeated occurrences from the same exhibitors may result in their being put on a CASH ONLY basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of the Show Committee.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

The show giving Club, the Show Superintendent, their agents, employees, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form.

Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Refunds of \$4.00 & less will not be issued due to the costs of processing.

An administrative fee of \$2.50 will be charged for all cancellations or changes made prior to closing of entries.

EXHIBITORS NOTE: Please notify Superintendent of any change of address.

Each Entry processed through Jack Onofrio Dog Shows Telephone Entry Service or Onofrio Online Entry will have a service fee included in the amount charged to the payment card provided. Each user of either service acknowledges they are authorized to charge fees to the card provided for payment and further acknowledges the transaction is made over the phone or internet. Chargebacks on cards are a violation of the agreement to pay all fees included in this premium list and can result in the club refusing future entries from the exhibitor, refusal of entries from the exhibitor by the superintendent until the debt has been paid and/or being placed on a cash only basis with the superintendent.

FAX/EMAIL ENTRIES AND PAPER ENTRIES WITH CREDIT CARD ARE NOT ACCEPTABLE METHODS FOR ENTRIES AND WILL NOT BE PROCESSED. **Online Entries and Checks by Mail are not affected by this change.** If mailing be sure to have the entry with check enclosed arrive prior to the closing date of the show. Please note all entries received via fax or email and/or paper entries with credit card information will be shredded/deleted immediately upon delivery without processing. With credit card security and identity theft concerns we are implementing this change to protect your information from potential abuse. Entry forms are occasionally viewed by others outside of the staff of the Superintendent. We will always be happy to accept entries with payment by check at any of our shows. Stop by and say hello.

All vehicles must be off the grounds by 8:00 pm on Sunday, or an extra day will be charged. Parking spaces are pre-assigned. PEOPLE WISHING TO PARK TOGETHER MUST SEND IN THEIR RESERVATIONS TOGETHER. Please provide a self-addressed, stamped envelope for Parking Acknowledgement. HANDICAPPED Parking is available with a photocopy of a valid handicapped license. (No request to park together unless both are handicapped.) No handicapped parking after close of reserved parking. Parking spaces are 40' x 22'. If vehicle exceeds these dimensions, additional space must be purchased. Tagalong or additional drive-in vehicles must fit in this space as well. One vehicle setup per parking space. Veteran Variety Groups will be held.

Section 1 - Classifications

- The Four-to-Six Month Puppy competition shall be for puppies that are over four months of age but under six months on the day of the event.
- Classes are offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3 Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show
- The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show

Section 2 - Entry and Eligibility

Entry and eligibility requirements include:

- Puppies must have one of the following:
 - An Individual registration number registered with the American Kennel Club (AKC)
 - A Foundation Stock Service (FSS) registration number
 - A foreign born dog may enter if they are registered in the country of origin, as defined in Chapter 11, Section 1 of the Rules Applying to Dog Shows
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may personally exhibit in the Four-to-Six Month (Beginner Puppy) Competition. Entries must be marked "Exhibition Only" prior to the close of entries.
- Dogs that are owned or co-owned by the forenamed may compete for awards in this competition but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month Beginner Puppy Competition.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have not won three (3) first place awards★, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have not won three (3) first place awards★, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have not won three (3) first place awards★, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have won three (3) first place awards★ in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have won three (3) first place awards★ in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards★ in a Novice Class at a licensed or member show, with competition present in the Novice Class.

MASTER CLASS - For Boys and Girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) Best Junior Handler awards with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

★ A first place in Novice without competition leading to a Best Junior award with competition counts as one win towards moving to Open.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. To obtain junior identification number contact juniors@akc.org

BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

AKC NATIONAL OWNER-HANDLED SERIES BOTH DAYS

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

All dogs that are owner-handled and are not exhibited in the National Owner-Handled Series by professional handlers* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants to professional handlers may not exhibit the dog in any AKC National Owner-Handled Series competition during the entire show. A current assistant is defined by anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend, however current assistants that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may participate in NOHS.**

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

**Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.*

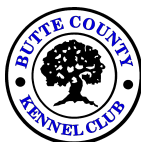
